

**City of White Georgia  
City Council Meeting  
April 5th, 2021**

Present at the meeting were Mayor Kim Billue, Councilmembers Dennis Huskins, Ryan Evans, Charles Buttrum, City Attorney Leslie Simmons.

The meeting was called to order by Mayor Billue. Councilmember Dennis Huskins opened the meeting with an invocation. Mayor Billue Lead the Room in the saying of the Pledge.

Mayor Billue swore in Curtis Powell as the newest Councilmember.

The Minutes from the March 1st, 2021 meeting were read. Councilmember Evans made a motion to approve the minutes. Council Member Huskins seconded the motion. Motion passed. 3-0

Mayor Billue made an apology for how the previous months meeting went, she thanked the Cities of Emerson and Adairsville with their help during our transition. And thanked the employees of the city for their work during the transition.

Billy Baker reported on the Richards Road project stating it was scheduled to start April 12<sup>th</sup>, however that had been delayed due the railroad. He had meeting with the engineering team to get the project back on tract. He also mentioned his work on updating the tap fee prices for the cities.

Billy then reported for the water department on a project to work on Aubrey Lake Lift Station, to deal with the sludge blanket that keeps shutting the station off and see about getting an agitator to help keep the stations running and had the council vote on a water study for the old Tennessee Hwy development motion was approved by councilmember Huskins on the grounds the developer paid for it, council member Evans seconded motion passed. 4-0

Chief Davidson introduced the newest officer Adam Knight, making the police department fully staffed. He also reported about past break ins, lose dogs in town, and phone scams, informing the public to call 911 first if there is an issue.

Attorney Leslie Simmons commented on the road annexation where the limits would be and the 2 meetings required and the groups that would need to be contacted to approve the annexation.

Mayor Billue then brought up new business:

- To vote Breanna Bellamy in as city clerk, Council member Huskins made a motion Council member Evans seconded the motion, motion passed. 4-0
- To vote on a resolution to add Breanna as a signer for the bank accounts. Council member Evans made a motion, Huskins seconded. Motion passed. 4-0

- To move the CDs from Ameris bank to another bank. Huskins made a motion Evans seconded. Motion passed. 4-0
- to get approval for building the new playground. Huskins made a motion on the ground we could put it together without voiding the warranty. Evans seconded the motion. Motion passed. 4-0
- To recommend Blake Davidson as the Chief. Evans made a motion Powell Seconded. Motion passed. 4-0

Mayor Billue then Swore in Davidson as the Police Chief.

Councilmember Huskins made a motion to adjourn Councilmember Evans seconded the motion. Motion passed. 4-0
