**WHEREAS**, the City previously approved an Alcohol Ordinance, providing for the regulation of beer, wine, distilled spirit, and other alcohol sales; and


**WHEREAS**, the City must amend the Alcohol Ordinance to correct an error regarding license fees.

**NOW THEREFORE BE IT RESOLVED**, AND IT IS HEREBY ORDAINED, by the virtue of the authority vested in the Mayor of the City of White, Georgia, that the Amendment to the City's Alcohol Ordinance is hereby approved and is incorporated into the Alcohol Ordinance.



## **Amendment to the Alcohol Ordinance**

The City hereby restates the Alcohol Ordinance in its entirety and makes the following amendment:

1. Section Four, Subsection 5(b) shall be amended to state:

Licenses for the sale of alcoholic beverages shall be issued by the City Clerk or his designee at an annual license fee as established herein:

- i. Retail consumption on the premises- \$4,500.00;
- ii. Retail sale with no consumption on the premises- \$2,000.00; and
- iii. Microbrewery license- \$3,500.00.

passenger of a bus, limo, or motor home in which the driver is operating the vehicle pursuant to a contract to provide transportation and such driver holds a valid chauffeur's license pursuant to state law.

- b. No person shall possess an open container of alcoholic beverage while walking, standing, or otherwise occupying any public street, road, highway, sidewalk, public park, or public parking lot. Consumption of alcoholic beverages in or on other publicly-owned properties of the City is prohibited.
  - c. No person shall possess an open container of an alcoholic beverage on the premises of any retail package licensee, including parking lots located adjacent thereto.
  - d. No person shall enter or leave the premises of an establishment licensed to sell or dispense alcoholic beverages for consumption on the premises with an open container of any alcoholic beverage.
3. No person in this City shall appear or be in an intoxicated condition in any public place or within the exterior property of any private residence not his own other than by invitation of the owner or lawful occupant, when such condition of intoxication is made manifest by boisterous, rowdy, indecent condition or act, vulgarity, or by vulgar, profane, loud, or obscene language.

## Section Four

### Licenses

1. No person shall hold a license to conduct sales of alcoholic beverages for consumption on the premises or a license to conduct retail package sales who also has an interest in a license to operate as a wholesaler or wholesale dealer.
2. No elected or appointed official, employee, or agent of the City, directly or indirectly shall be a licensee under this Code.
3. No elected or appointed official or employee of the city may hold an interest in a license issued under this Code.
4. It shall be unlawful for any person to manufacture for sale, or possess, for the purpose of sale, any alcoholic beverage where such person does not have a license from the city to sell or possess for sale such alcoholic beverage.
5. Licenses required to sell alcoholic beverages:
  - a. Any person desiring to sell alcoholic beverages in the City, whether for consumption on the premises or via retail package sale, shall apply for and obtain a license from the city prior to commencing operations. Operating without a license shall be a violation of this Code and shall be punishable
  - b. Licenses for the sale of alcoholic beverages shall be issued by the city clerk or his designee at an annual license fee as established herein:
    - i. Retail consumption on the premises- \$4,500.00;
    - ii. Retail consumption on the premises- \$2,000.00; and
    - iii. Microbrewery license- \$3,500.00.
  - c. All licenses issued herein shall constitute a mere grant of a privilege to carry on such business during the term of the license subject to all the terms and conditions imposed by this Code, related ordinances, state law and regulations, and federal laws and regulations applicable to such business.
